General Assembly Elects New President and Board of Directors

During the EUROLAB General Assembly & Accompanying Events on April 28-29 in Copenhagen, Denmark, the General Assembly elected the new President and the Board of Directors.

Andreas Kinzel, EUROLAB-Germany, is the newly elected EUROLAB President. Andreas has held the title of President of the German Association of Materials Testing Institutes (VMPA) in Berlin for the past 19 years and he is a member of the Board of the German national laboratory association EUROLAB-Germany as of 2006 and its Vice President since 2017. He is also a member of the German Accreditation Council and became the acting chairman in 2023. After obtaining his PhD in engineering, he began his career in the field of laser research. Then, he joined the Lower Saxony Materials Testing Institute in 1993, and later became the Director of the Lower Saxony Agency for Fundamental Aspects in Conformity Assessment.
